THESE PRESERVED LANDS PROVIDE COMMUNITY OPPORTUNITIES FOR OUTDOOR RECREATION, EDUCATION AND CLIMATE RESILIENCE. EACH YEAR, HUNDREDS OF LOCAL STUDENTS VISIT OVLC PRESERVES FOR OUTDOOR EDUCATION PROGRAMS, IN ADDITION TO THE TENS OF THOUSANDS OF VISITORS WHO ENJOY HIKING, BIKING, HORSEBACK RIDING AND MORE.

THE OVLC CURRENTLY MANAGES ROUGHLY 2,400 ACRES OF OPEN SPACE IN THE OJAI VALLEY OF WHICH 2,000 ACRES ARE OPEN FOR FREE PUBLIC ACCESS. OVLC HAS SEVERAL NEW PROJECTS THAT HAVE THE POTENTIAL TO ADD ADDITIONAL PROTECTED LAND.
